## Admission Requirements

#### First attempt students:

Students from a SAICA accredited undergraduate degree: Applicants with a SAICA-accredited undergraduate degree must have completed all 4 major 3rd year subjects - Auditing, Financial Accounting, Management Accounting and Finance and Taxation - in the year immediately preceding the year in which they are admitted into the PGDip (Accounting), OR A successfully completed accountancy bridging programme and completed all 4 major subjects - Auditing, Financial Accounting, Management Accounting and Finance and Taxation - in the year immediately preceding the year in which they are admitted into the PGDip (Accounting).

#### Repeat attempt students

Note: Students who have unsuccessfully attempted their PGDip (Accounting) or equivalent once, in the year preceding registration for PGDip (Accounting) at either The IIE or any other higher education provider, will be admitted into The IIE's PGDip (Accounting) programme on condition that their average for their first attempt of PGDip (Accounting) or equivalent was at least 40%. Students who have unsuccessfully attempted their PGDip (Accounting) or equivalent two times or more at either The IIE or any other higher education provider, will not be admitted into The IIE's PGDip (Accounting) programme.
